PROCEDURAL ORDER

BY THE COMMISSION:

On November 21, 2013, Naco Water Company, LLC (“NWC” or “Company”) filed with the Arizona Corporation Commission (“Commission”) an Application for a rate increase.

On December 11, 2013, NWC filed an Amended Rate Application.

On December 20, 2013, The Commission’s Utilities Division (“Staff”) filed a Letter of Deficiency informing NWC that there were deficiencies in its Application and giving the Company until January 6, 2013, to correct the deficiencies.

On December 27, 2013, on behalf of NWC, Staff filed a Request for An Extension of Time to Resolve Insufficiency. Staff states that NWC has requested until January 24, 2014, to correct the identified deficiencies and that Staff has no objection to the requested extension.

The request is timely and providing the company an opportunity to file a complete and accurate Application is in the public interest.

IT IS THEREFOR ORDERED that the deadline for the Company to address Staff’s identified deficiencies is extended to January 24, 2014.


