STAFF REQUEST FOR EXTENSION

On July 2, 2013, Cerbat Water Company ("Cerbat" or "Company") filed an application for a rate increase in the above captioned docket. On October 31, 2013, Commission Utilities Division Staff ("Staff") filed its Staff Report evaluating the application. On November 14, 2013, Staff filed an additional Amended Staff Report. On November 18, 2013, Staff filed a Notice of Errata correcting errors in the rate design presented in the Amended Staff Report. On November 26, 2013, a Procedural Order was issued directing Staff to file by January 8, 2013 a Revised/Amended Staff Report responding to a number of specified inquiries.

Some of the specified inquiries directed to Staff required further information to be supplied by Cerbat in order for Staff to respond. For example, Staff required additional information regarding principal and interest payments on current WIFA loans, clarifications of AIAC refunds actually made by year from 2010 through 2013, as well clarifications regarding the Company's debt reserve payment requirements. Staff received the requesting information on January 3, 2014. Due to the time necessary to analyze and review the additional information, Staff requests a seven day extension
