Applicant Union Pacific Railroad Company ("Union Pacific"), by and through its attorneys Beaugureau, Hancock, Stoll & Schwartz, P.C., pursuant to the Commission's Decision No. 70618 in this docket, files as a compliance item in this docket the following update on the average daily traffic count concerning the three crossings described in the Application. This information was obtained from Duane S. Eitel, who is the Traffic Engineer for the City of Casa Grande, which is the road authority for all three crossings described in the Application. The only traffic count available in the vicinity of any of the three crossings was the one for Florence Street.

Florence Street: The actual Average Daily Traffic ("ADT") count for the current at-grade crossing of Florence Street with Union Pacific's railroad tracks in February, 2012, the most recent information available, was 2,748 vehicles per day (south of 2nd), a decrease from the 3,048 vehicles per day in 2007 as stated in the Commission's Decision No. 70618. The City of Casa Grande was unable to provide any recent projections of ADT at Florence Street.
