Ms. Reidhead - this will confirm that you have declined our offer to work out a resolution of your scheduling conflict because you believe that the Company's supplemental rejoinder must also address your data requests to PWC. This is not our belief.

Judge Nodes ordered the Company to address the condemnation issue raised in your testimony and Ms. Brown's, and we will. He also indicated that we could address any other issue we believe appropriate. But he did not, in any way that we heard, direct the Company to answer the data requests to which it has objected.

Therefore, in summary, our objections stand and we will respond to your motion tomorrow.

If I have misstated your position in any way, please let me know promptly.

I would also note, the reason you have not previously been emailed on filings is because your email address is not on your pleadings. Now that we have it because I asked for it yesterday to send you discovery requests, we will email all filings to you the day they are filed. We ask that you extend us the same courtesy.
