**STAFF'S REQUEST FOR EXTENSION**

On July 31, 2013, the Estate of William F. Randall dba Valle Verde Water Company ("Company") filed an application for a rate increase. By Procedural Order dated September 5, 2013, Commission Staff was directed to file its Direct Testimony evaluating the Company's application by January 13, 2014. Due to continuing review of the engineering analysis and the proximity of the impending Commission Open Meeting, Staff requests an extension of two days to file its engineering testimony. Therefore, Staff requests an extension to file the engineering portion of the Staff Direct Testimony by January 15, 2014.

Staff is separately filing the testimony of Gerald Becker relating Staff's rate base, revenue requirement and rate design analysis, as well as all other Staff recommendations other than those contained in the engineering analysis. Staff attempted to contact the Company's attorney regarding Staff's limited request for extension but he was unavailable and so Staff left a message explaining Staff's request. Due to the limited nature of Staff's requested extension, Staff anticipates no prejudice from granting the request.
