
15 In compliance with Paragraph 42.h of Decision No. 74011, Nexus Communications,  
16 Inc. ("Nexus"), by its counsel, hereby files its quarterly report detailing the total number of  
17 Lifeline customers, the total number of customers removed from the customer base due to  
18 60-day inactivity, the number of customers removed from the customer base due to annual  
19 verification, the total number of customers who voluntarily relinquished Lifeline service  
20 and the number of customer complaints that have been filed with Nexus arising from its  
21 ETC service offerings in Arizona.

22 Although Nexus began offering Lifeline-supported services in Arizona in October  
23 2013, the company is in the process of ramping up its marketing efforts in the State.  
24 Nexus hereby notifies the Arizona Corporation Commission that as of December 31, 2013,  
25 Nexus had no subscribers receiving Lifeline-supported services in Arizona. Therefore,  
26 there is no responsive information to report for the quarter ending December 31, 2013.


