Having considered the entire record herein and being fully advised in the premises, the Commission finds, concludes, and orders that:

FINDINGS OF FACT

1. On October 25, 2013, the Arizona Corporation Commission (“Commission”) issued Decision No. 74155 which approved an application by Cordes Lakes Water Company (“Applicant” or “Company”) for an increase in its rates and charges.

2. As a result of the Commission’s Decision which approved the rate increase, the Company was also ordered to do the following:

- file, within six months of the effective date of the Decision, with the Commission, an application for financing approval for the cost of improvements to prevent water losses; and
- file, within 180 days of the effective date of the Decision, with the Commission, an application for an extension of its Certificate of Convenience and Necessity where the Company is providing service to customers outside of its certificated service area.
