On September 12, 2013, Arizona Administrative Law Judge Jane L. Rodda set
forth the following procedural schedule:



Dates range from February 20, 2014 to May 8, 2014.

1 On or about January 21, 2014, Staff propounded its Third Set of Data Requests on
2 Company to be responded to within ten calendar days. Based upon the Company's
3 employee work schedules, the Company has requested a two-week extension to respond
4 to those Data Requests. Given the current procedural schedule, in order to allow Staff
5 sufficient opportunity to review those responses, and prepare its direct testimony, the
6 parties have agreed to the following modification to the Procedural Schedule as follows:

7 Staff's and/or Intervenor's Direct Testimony – 8 all-includes rate design and cost of service	On or before March 6, 2014;
9 Company Rebuttal Testimony	On or before April 3, 2014;
10 Staff's and/or Intervenors' Surrebuttal 11 Testimony	On or before April 25, 2014;
12 Company Rejoinder Testimony 13 Hearing	On or before May 5, 2014; and May 8, 2014
