I believe the proposed "Curtailment Plan" and rate hike requested by the Payson Water Company is unjust to the residents of East Verde Park. The increased rates would pose undue hardship on many of the residents that are on fixed incomes.

The EVP Curtailment plan should be deemed invalid as it was not included on any of the public notices. The criteria for determining the violations is unreasonable. For example; I will have house guests, some from out of state, some from out of country, during the curtailment period. I will definitely use more water during my guests visits than the prior month as I will be adding up to four people to my household during these visits. As I will have guests at various times during the curtailment period, I could easily be found in violation 2-3 times during this time. So I would be disconnected and fined up to \$3000 just for having house guests! That seems more like intimidation and harassment than good business practices to me.

Also, the water hauling charges should not be considered since the water hauling would not be necessary if the Payson Water Company would just make the improvements that were requested by the residents in 1976 and promised in 2001 by Payson Water Company's President, Robert Hardcastle.

Please do not approve the rate hike and EVP Curtailment Plan as proposed by Payson Water Company. These would only cause undue hardship on the residents of East Verde Park, an already very water conscious community.
