PROCEDURAL ORDER

BY THE COMMISSION:

On September 25, 2013, Richard Gayer ("Complainant") filed with the Arizona Corporation Commission ("Commission") a Formal Complaint against Southwest Gas Corporation ("SWG" or "Company"), alleging various improprieties with respect to SWG's implementation of its energy efficiency enabling provision, a revenue decoupling mechanism approved by the Commission in the Company's last rate case (Decision No. 72723, January 6, 2012).

On October 23, 2013, SWG filed its Answer to Formal Complaint, generally denying the material allegations in the Complaint.

On February 3, 2014, the Complainant filed a Motion to Schedule Prehearing Conference.

IT IS THEREFORE ORDERED that a procedural conference shall be scheduled in this matter for March 4, 2014, at 10:00 a.m., at the offices of the Commission, Hearing Room 1, 1200 West Washington, Phoenix, Arizona 85007.
