

This letter is submitted by Pollux Properties, L.L.C. ("Pollux Properties") in support of Ridgeline Water Company, L.L.C.'s ("Company") Motion for Further Extension of Compliance Filing Deadline Date ("Motion"), as filed with the Commission's Docket Control on January 7, 2014 in the above-referenced docket.
