OF EXTENSION



The Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") and Sulphur Springs Valley Electric Cooperative ("Sulphur Springs") hereby give notice of and stipulate to an extension of time for Staff to file its Staff Report and proposed order until February 21, 2014. This matter is being processed in accordance with A.A.C. R14-2-107. Sulphur Springs is a Class A utility. According to A.A.C. R14-2-107(M)(4)(a), Staff is required to file its Staff Report in this matter within 120 days after filing a notice of sufficiency. Staff filed the notice of sufficiency in this matter on October 23, 2013. Therefore the Staff Report in this matter was due on February 20, 2014. However, for various reasons, Staff needs additional time in which to docket the Staff Report in this matter. It is not clear in these rules whether the Administrative Law Judge ("ALJ") needs to grant any extensions of time for the procedural deadlines set forth in A.A.C. R14-2-107. However, to the extent the Commission desires that the assigned ALJ address any procedural requests, Staff and Sulphur Springs hereby stipulate to and request an extension of time for Staff to file the Staff Report


