**JOINT MOTION FOR MODIFICATION
OF PROCEDURAL SCHEDULE**

The Utilities Division Staff ("Staff") of the Arizona Corporation Commission ("Commission") and Valle Verde Water Company ("Company") hereby jointly request a procedural change in the instant docket.

As the parties hereto noted in their February 19, 2014, Joint Motion for an Extension of Time ("Extension Request"), their Surrebuttal and Rejoinder testimony were originally due on February 21, 2014, and March 3, 2014, respectively. In the Extension Request, the parties sought additional time to submit such testimony due to settlement discussions which were scheduled to take place February 21, 2014. Such negotiations commenced as scheduled and resulted in the parties reaching a settlement agreement resolving all issues in this matter. The exact terms of the settlement agreement are presently being finalized.

As a result of the settlement agreement, the parties request that the procedural schedule be amended to reflect that the proposed settlement agreement be due on March 4, 2014, in lieu of both Staff's Surrebuttal and the Company's Rejoinder testimony filings.


1 Staff and the Company addressed the amended schedule as part of the settlement discussions
