ADMINISTRATIVELY CLOSING
DOCKET

BY THE COMMISSION:

On January, 6, 2014, Peerless Network of Arizona, Inc. ("Peerless") and IntelPeer, Inc. ("IntelPeer") (collectively "the Parties"), filed an informational letter advising the Arizona Corporation Commission ("Commission") that the Parties entered into a stock purchase agreement to which Peerless acquired ownership of IntelPeer. According to the Parties, the agreement does not result in the assignment away from IntelPeer of any Certificates of Convenience and Necessity or intrastate telecommunications assets in Arizona.

On February 7, 2014, the Commission's Utilities Division ("Staff") filed a Memorandum recommending that these dockets be administratively closed. According to Staff, the Commission is not obligated to review or consider the agreement discussed in the informational letter. Staff notes that administrative closure should not be construed as either an approval or denial by the Commission.

Staff's recommendation is reasonable and should be granted. Accordingly, these dockets should be administratively closed.
