PROCEDURAL ORDER ADMINISTRATIVELY CLOSING DOCKET

BY THE COMMISSION:

On July 28, 2004, MCImetro Access Transmission Services, LLC ("MCImetro") filed an application with the Arizona Corporation Commission ("Commission") seeking approval of a negotiated amendment to an Interconnection Agreement between MCImetro and Qwest Corporation ("Qwest") and for approval of a QPP Master Service Agreement.

On August 6, 2004, Qwest filed a Motion to Dismiss Application for Review of Negotiated Commercial Agreement (with Alternative Request for Intervention).

In Decision No. 68116 (September 9, 2005), the Commission denied Qwest's Motion to Dismiss and ruled, among other things, that consideration of the agreements filed with MCImetro's Application is within the Commission's jurisdiction.

On September 28, 2005, Qwest filed an Application for Rehearing.

On January 23, 2006, John M. Devaney filed a Motion and Consent of Local Counsel for pro hac vice admission on behalf of Qwest.

On February 10, 2006, a Procedural Order was issued admitting John M. Devaney to appear as counsel pro hac vice in the above-captioned matter.

On February 12, 2014, a Procedural Order was issued directing the Commission's Utilities Division ("Staff") to file an update on the status of this matter, or make a procedural recommendation indicating whether the matter should be administratively closed.

On February 20, 2014, Staff filed a Memorandum recommending that these dockets be

1 administratively closed. Staff states that the agreements filed with MCImetro's Application are
2 within the Commission's jurisdiction to review and approve. According to Staff, the agreements
3 went into effect by operation of law. There were no filed objections to Staff's recommendation.

4 Staff's recommendation is reasonable and should be adopted. Since no further action by the
5 Commission is required, these dockets should be administratively closed.

6 IT IS THEREFORE ORDERED that Docket Nos. T-01051B-04-0540 and T-03574A-04-
7 0540 are hereby administratively closed.
