PROCEDURAL ORDER  
(Schedules Procedural Conference)

BY THE COMMISSION:

On December 31, 2013, Johnson Utilities, LLC, ("Johnson Utilities") filed with the Arizona Corporation Commission ("Commission") the above-captioned application.

By Procedural Order issued February 14, 2014, the February 4, 2014 Motion to Intervene filed by Swing First Golf LLC ("Swing First") was granted.

On March 4, 2014, the Commission's Utilities Division ("Staff") filed a Letter of Sufficiency indicating that the application and information provided to Staff is sufficient for Staff to begin its substantive review of the application. Staff stated in its Letter of Sufficiency that Johnson Utilities should provide notice of the application to all affected parties.

A procedural conference should be held to allow the parties to discuss appropriate notice and an appropriate procedural schedule for the hearing in this matter.

IT IS THEREFORE ORDERED that a **procedural conference** shall be held on **March 13, 2014, at 1:30 p.m.**, at the Commission's offices, 1200 West Washington Street, Hearing Room No. 1, Phoenix, Arizona.

IT IS FURTHER ORDERED that all parties must comply with Arizona Supreme Court Rules 31, 38, and 42 and A.R.S. § 40-243 with respect to the practice of law and admission *pro hac vice*.
