NOTIFICATION OF INTERVENTION

BY THE COMMISSION:

On January 10, 2014, UNS Energy Corporation (“UNS Energy”) on behalf of itself and its affiliates, and Fortis Inc. (“Fortis”) on behalf of itself and its affiliates, (collectively, “Joint Applicants”) filed with the Arizona Corporation Commission (“Commission”) pursuant to Arizona Administrative Code (“A.A.C.”) R14-2-803 a Joint Notice of Intent to Reorganize (“Joint Notice”).

On February 18, 2014, Arizona Public Service Company (“APS”) filed a Motion to Intervene in this matter. The same date, Arizona Community Action Association (“ACAA”) and Ms. Cynthia Zwick also filed Motions to Intervene.

APS is a public service corporation that sells electric power to UNS Energy’s subsidiary Tucson Electric Power Company (“TEP”) and on occasion purchases power from TEP; APS and TEP have interconnected transmission systems; and APS and TEP are co-owners of certain electric facilities.

ACAA and Ms. Zwick serve the interests of low-income Arizona’s living within the service territories of UNS Energy, TEP and UNS Electric, Inc. and UNS Gas, Inc.. Ms. Zwick is the Executive Director of ACAA.<sup>1</sup> ACAA’s Motion states that Ms. Zwick is authorized to represent ACAA in this proceeding. According to the information provided in the Motion, Ms. Zwick meets the requirements for lay representation before the Commission pursuant to Arizona Supreme Court

2 No party objected to the requests to intervene.

3 IT IS THEREFORE ORDERED that APS's, ACAA's and Ms. Zwick's requests to intervene  
4 are granted.

5 IT IS FURTHER ORDERED that Cynthia Zwick is hereby authorized to represent ACAA in  
6 this proceeding pursuant to Arizona Supreme Court Rule 31(d)(28). In the discretion of the  
7 Commission, counsel in lieu of lay representation may be required whenever the Commission  
8 determines that lay representation is interfering with the orderly progress of the proceeding, imposing  
9 undue burdens on the other parties, or causing harm to the parties represented.


