NOTIFICATION OF INTERVENTION

BY THE COMMISSION:

On January 10, 2014, UNS Energy Corporation (“UNS Energy”) on behalf of itself and its affiliates, and Fortis Inc. (“Fortis”) on behalf of itself and its affiliates, (collectively, “Joint Applicants”) filed with the Arizona Corporation Commission (“Commission”) pursuant to Arizona Administrative Code (“A.A.C.”) R14-2-803 a Joint Notice of Intent to Reorganize (“Joint Notice”).

On February 25, 2014, Local Unions 387, 769 and 1116, International Brotherhood of Electrical Workers, AFL-CIO (“IBEW Local 387” “IBEW Local 769” and “IBEW Local 1116” collectively “IBEW Locals”) filed an Application for Leave to Intervene in this matter.

The IBEW Locals are the bargaining representatives of various units of non-managerial employees of Tucson Electric Power Company, UNS Electric, Inc. and UNS Gas, Inc. In their application, IBEW Locals assert facts that demonstrate that their members will be directly and substantially affected by the proceeding.

No party objected to the request to intervene.




