NOTIFICATION OF INTERVENTION

BY THE COMMISSION:

On December 31, 2013, UNS Electric, Inc. ("UNSE" or "Company") filed an Application with the Arizona Corporation Commission ("Commission") seeking approval of an accounting order authorizing the deferral for future recovery of non-fuel costs associated with the Company's prospective purchase of up to a 25 percent interest in Unit 3 at the Gila River Power Plant.

On February 28, 2014, Arizona Public Service Company ("APS") filed a Motion to Intervene in this matter. APS is a public service corporation providing electric service to customers in Arizona and sells and purchases electric power on the wholesale market. APS states that it currently has a purchased power tolling agreement with the Gila River Power Station.

On February 25, 2014, the Residential Utility Consumer Office ("RUCO") filed an Application to Intervene. RUCO was established for the purpose of representing residential utility consumers in matters before the Commission concerning regulated public service corporations.

No party objected to the intervention requests.

IT IS THEREFORE ORDERED that APS' and RUCO's requests to intervention are granted.


