STAFF'S MOTION TO CONSOLIDATE

ORIGINAL

IN THE MATTER OF THE APPLICATION OF  
ARIZONA EASTERN RAILWAY COMPANY  
FOR APPROVAL TO FURNISH AND  
INSTALL 3 GATE AND FLASHER UNITS ON  
CENTERPOINT RD/AZER HIGHWAY-RAIL  
CROSSING AND CONSTANT WARNING  
CIRCUITRY.

On February 27, 2014, Arizona Department of Transportation ("ADOT") filed three applications with the Arizona Corporation Commission ("Commission") to authorize the Arizona Eastern Railroad to modify three railroad crossings. The three crossings have all previously been included on Commission approved crossing arrays. Likewise, all three crossings are located in close geographical proximity to the town of Bylas Arizona within the San Carlos Apache Indian Reservation. Due to the common factual circumstances surrounding each of the crossings and the close geographical proximity of the crossings, Staff believes that it would be more efficient and helpful for the matters to be considered together rather than individually.

Arizona Corporation Commission Utilities Division Staff hereby moves to consolidate Docket Nos. RR-02634A-14-0064, RR-02634A-14-0065 and RR-02634A-14-0066. The issues involved in these matters are substantially related and no parties' rights will be prejudiced by consolidation. Staff believes that consolidation of these matters will aid the Commission in its evaluation of all three.
