The Arizona Corporation Commission ("Commission") opened the above-captioned docket on November 4, 2013.

On January 21, 2014, Arizona Community Action Association and Cynthia Zwick filed a Motion to Intervene in this matter. ACAA and Ms. Zwick serve the interests of low-income Arizonans. Ms. Zwick is the Executive Director of ACAA.¹ ACAA's Motion states that Ms. Zwick is authorized to represent ACAA in this proceeding. According to the information provided in the Motion, Ms. Zwick meets the requirements for lay representation before the Commission pursuant to Arizona Supreme Court Rule 31(d)(28).

No party objected to the requests.


IT IS THEREFORE ORDERED that ACAA and Ms. Zwick's requests to intervene are granted.


