TRUXTON CANYON WATER COMPANY RATE CASE HEARING  
WEDNESDAY FEBRUARY 26, 2014

GREETING: Good morning Judge Kinsey and Commissioners.

My name is Vicki Hoag; I live at 7472 E Sawmill Drive, Valle Vista, Kingman AZ. Just a brief history; my husband Glenn and I have followed this case from its inception both in the field and at the hearings here in Phoenix. We moved into our newly built home in April 2009. Over the last 5 years several things concerning our water supply provided by TCWC have occurred.

A. We had to install a water pressure regulator to prevent the fluctuating water pressure from Truxton's gravity fed system from "blowing out" seals and pipe joints in our home. We were not advised by TCWC to put in a valve upon original build;

B. We installed an under sink small RO system to combat the constantly high arsenic levels in our drinking water. This cost us approximately \$300 to install with a yearly filter replacement cost of \$85.

C. Have worked with TCWC, the ACC Staff and ADEQ Staff to identify & fix over 27 leaks in the water system throughout Valle Vista, 2 of which directly affected our home.

We do have to give credit to Mr. Rick Neal who has worked hard to bring the leaks and the repairs under control in a timely manner.

I am appearing before you today on behalf of myself and 245 residents of Valle Vista who are also TCWC customers as well as some from Arizona West, also TCWC customers, to present the petition you have before you. This petition states that the undersigned, as well as those who sent in emails if they were unable to physically sign the petition, support the ACC Staff recommendations regarding the rate case before you that TCWC has submitted for approval.

The undersigned agree with the following ACC Staff recommendations, but not limited to:

1. Minimum delivery charge dropped from \$19.50 to \$14.50;
2. Rates for the first 1-5000 gals delivered be dropped to 1-3000 gals & the rate to be \$1.20/1000 gals;
3. Rates for 3,000-10,000 gals be \$2.20/1000 gals;
4. Rates over 10,000 be \$3.764/1000 gals;

5. TCWC be allowed to borrow \$259,280 from WIFA for the installation of the Arsenic Treatment Plant;
6. Support the \$2.15 per month surcharge for the recovery cost of this plant;
7. Support the ACC Staff recommendation that the current system be transferred from the Claude K Neal Trust to TCWC "as is". The residents do NOT support TCWC borrowing \$1.4 mil to finance this transfer, as both entities are owned by the same person as a single shareholder in both entities.

We agree that TCWC is due a rate increase since they have not applied for one since 2001, but not with also providing the Trust with a windfall to its single shareholder at the expense of the customers, who would be financing the "sale" of the system to the same person, who is a shareholder in both entities.

We ask that the ACC enforce their laws and regulations regarding the high arsenic levels recorded in TCWC potable water, including reporting and penalties for not providing safe drinking water.

Going forward from the date the rate case is approved, we ask that the ACC instruct TCWC to inform new home builders of the arsenic issue and to install a small under sink RO system until their arsenic plant is completed and prove that it is operating correctly, removing the arsenic from the potable drinking water.

We also ask the ACC to instruct TCWC to install water pressure safety valves with each new build to prevent fluctuating pressure issues in homes.

**Truxton Rate Increase Case W-02168A-11-0363, W-02168A-13-309 & W-02168A-13-0332**

In the current rate case request before the Arizona Corporation Commission concerning Truxton Canyon Water Company, the Commission Staff is recommending that Residential Minimum Charge Rates be REDUCED from \$19.50/month to \$14.00/month, and that water usage rates be adjusted in the following manner (see Chart below);

The above rates are for a residential 5/8" x 3/4" or 3/4" meter. The noticeable change is in the amount of gallons that the costs are figured on, for example changing from the first 1-5,000 gallons (currently) to the first 1-3,000 gallons (proposed). While the rate would stay the same per ACC Staff Recommendations, (\$1.20), after 3,000 gallons the rate would go up to \$2.20 (ACC STAFF PROPOSED RATE).

Truxton has requested approval for a loan through WIFA (Water Infrastructure Financing Authority) in the amount of \$419,208 to install an arsenic treatment plant. Based on Staff research, they are recommending approval of \$259,280 for the plant.

Additionally, a surcharge rate for the arsenic plant would result in a charge of \$2.15 per month per customer until the money for the arsenic plant is repaid. Staff supports this amount.

Staff recommends that the request for \$1.4 million to purchase the wells, transmission lines and plant from the Claude K Neal Trust (which already owns 100% of Truxton Canyon Water Company Stock) by Truxton be denied for several reasons, one of which is the fact that the lines, wells and plant have been fully depreciated already; this would be applying "affiliate profit" to Truxton customers as they have already paid for the system through the past years.

The hearing is scheduled for Tuesday January 21 10:00 AM, Hearing Room 1, in Phoenix. There will be time allowed for Public Comment at the beginning of the hearing. The petition will be presented to the Commission at that time. Everyone is welcome to attend.
