NOTIFICATION OF INTERVENTION

BY THE COMMISSION:

On December 4, 2013, Table Top Telephone Company, Inc. ("Table Top") filed with the Arizona Corporation Commission ("Commission") pursuant to A.R.S. §40-250 and Arizona Administrative Code ("A.A.C.") R14-2-103 for an increase in its residential rates in order to compensate for the rate impacts of the Federal Communication Commission's ("FCC") November 18, 2011, USF/ICC Transformation Order ("*USF/ICC Order*").

By Procedural Order dated January 24, 2014, the matter was set for hearing on March 25, 2014, and other procedural guidelines were established.

On March 5, 2014, Linda J. Sharp, a customer of Table Top filed a request to intervene in this matter.


No party objected to the request.¹

¹ According to the schedule established in the January 23, 2014 Procedural Order, any intervenor direct testimony is due to be filed with docket control (original and 13 copies) by March 18, 2014. As an intervenor, Ms. Sharp may, but is not required to file testimony on her own behalf; in any event, as an intervenor, she is entitled to make an opening statement and closing argument, as well as cross examine witnesses.
