





NOTICE OF REQUEST FOR EMERGENCY/INTERIM RATE RELIEF

On March 7, 2014 Montezuma Rimrock Water Company L.L.C. ("Company") filed an application with the Arizona Corporation Commission in the above referenced dockets requesting authorization to implement emergency/interim rate increases sufficient to cover lease payments for its Arsenic Treatment Facility. The Company filed this request for relief because the Company does not currently have sufficient revenue to make lease payments for the Arsenic Treatment Facility that is currently in operation and providing service to customers. The Company's request is subject to true-up or refund upon a final decision in pending dockets, one of which is the Company's application for a permanent rate increase.
