


**LEAP FROG TELECOM, L.L.C. DBA VOCE TELECOM
QUARTERLY COMPLIANCE REPORT
DUE March 31, 2014**

Pursuant to Decision No. 74151 issued on October 25, 2013 in Docket No. T-20584A-10-0319, par. 57, Leap Frog Telecom, L.L.C. dba Voce Telecom ("Voce") submits this Quarterly Compliance Report for 1st Quarter of 2014.

Voce is in compliance with all Commission rules and orders and all laws administered by the Arizona Corporation Commission, and there have been no violations of such rules, orders or laws during quarter covered by this report.

During the quarter covered by this report, there was one regulatory compliance issue or complaint in the other jurisdictions in which Voce operates, including the FCC's interstate jurisdiction. Specifically, a consumer complaint was filed with the FCC on February 5, 2014 (Complaint No. 14-C00552007-1), in which the consumer alleged that they were misled when they switched their long distance service to Voce. Voce responded to the FCC on March 5, 2014 with appropriate documentation to support the transaction.

The facts above set forth herein are true and correct to the best of my knowledge, information, and belief.
