NOTICE OF COMPLIANCE FILING

Decision Nos. 68825, 69173 and 69181 order EPCOR Water Arizona Inc. ("Company")
to file by April 1st of each year subsequent to any year in which it collects surcharges under an
ACRM, a report with Docket Control, as a compliance item in this docket, showing the
Company's ending capital structure (equity, long-term debt, and short-term debt) by month for
the prior year. These decisions refer to ACRM surcharges collected in Agua Fria Water, Sun
City West and Havasu Water districts which are no longer effective. Therefore, as the Company
is no longer collecting ACRM surcharges for any of these districts this compliance item is no
longer valid.
