STAFF'S REQUEST FOR AN EXTENSION  
OF TIME TO FILE ITS STAFF REPORT

ORIGINAL

Applicant filed a request to increase its residential rates as necessary to compensate for the rate impacts of the Federal Communications Commission's ("FCC") November 18, 2011 Comprehensive Universal Service and Inter-carrier Compensation Reform Order ("Transformation Order"). The Transformation Order provides that if a carrier's rates are not equal to or higher than the FCC's rate floor, the carrier's federal high-cost loop support will be reduced by the amount their flat-rate residential local service rates fall below the floor.

Because the FCC has not yet determined the rate floor for June 1, 2014, and other recent developments at the federal level, which increase the uncertainty as to when the rate floor will be set and what its effective date will be, Staff requested a suspension of the procedural schedule in this case.


