NOTIFICATION OF INTERVENTION

BY THE COMMISSION:

On January 10, 2014, UNS Energy Corporation (“UNS Energy”) on behalf of itself and its affiliates, and Fortis Inc. (“Fortis”) on behalf of itself and its affiliates, (collectively, “Joint Applicants”) filed with the Arizona Corporation Commission (“Commission”) pursuant to Arizona Administrative Code (“A.A.C.”) R14-2-803 a Joint Notice of Intent to Reorganize (“Joint Notice”).

On March 12, 2014, the Arizona Investment Council (“AIC”) filed a Motion to Intervene in this matter.

AIC states that its mission includes the promotion of policies which encourage utility investment and infrastructure development in Arizona as well as to represent the interests of debt and equity investors in Arizona utilities.

No party objected to the request to intervene.
