STAFF SUPPLEMENT REGARDING
BMPs

Open Meeting
April 8 and 9, 2014

BY THE COMMISSION:

On April 1, 2014, and subsequent to the issuance of the Recommended Opinion and Order ("ROO"), Lagoon Estates Water Company, Inc. ("Lagoon Estates") selected and docketed three Best Management Practices ("BMPs") for implementation in its service territory. Staff has reviewed the BMPs selected by Lagoon Estates and finds them to be relevant to its service area and in conformance to the templates developed by Staff. In the interest of administrative efficiency, Staff recommends the following changes be made to the ROO, approving the three BMPs selected by the Company:

INSERT the following after Finding of Fact No. 39, Page 10, Line 16:

40. On April 1, 2014, Lagoon Estates selected and docketed three proposed BMPs which include the Public Education Program, 3.6 (Customer High Water Use Inquiry), and 5.2 (Water System Tampering).

41. Staff concluded that Lagoon Estates' proposed BMP Tariffs are relevant to Lagoon Estates' service area and that the proposed BMP Tariffs conform to the templates

1 developed by Staff. Staff has recommended approval of the three BMP tariffs docketed by
2 the Company on April 1, 2014.

4 **DELETE** the Ordering Paragraphs starting on Line 22 on Page 13, and ending on Line 1,
5 Page 14.

6 **INSERT** the following Ordering Paragraphs:

7 "IT IS THEREFORE ORDERED that the BMP Tariffs docketed by Lagoon Estates
8 Water Company, Inc. on April 1, 2014 are hereby approved.

9 IT IS FURTHER ORDERED that Lagoon Estates Water Company, Inc. shall notify
10 its customers, in a form acceptable to Staff, of the BMP Tariffs authorized herein and their
11 effective date by means of either an insert in the next regularly scheduled billing or by a
12 separated mailing and shall provide copies of the BMP Tariffs to any customer upon
13 request.

14 IT IS FURTHER ORDERED Staff shall file a letter in the Docket confirming that
15 Lagoon Estates Water Company, Inc.'s tariffs have been updated with the tariffs approved
16 herein.

17 IT IS FURTHER ORDERED that the Lagoon Estates Water Company, Inc. BMP
18 Tariffs authorized herein shall go into effect 30 days after the date notice is sent to
19 customers."
