MOHAVE ELECTRIC COOPERATIVE, INCORPORATED'S NOTICE OF SUPPORT OF STAFF'S REPORT

Mohave Electric Cooperative, Incorporated ("Mohave" or the "Cooperative"), by and through its undersigned attorneys, hereby files its Notice of Support of Staff's Report filed in the above consolidated dockets. Mohave originally filed its application to approve a modest Energy Efficiency and Demand Side Management Plan and Tariff over 2 ½ years ago. The Plan encompasses programs the Commission has previously approved for other electric utilities and at budget levels that will not impose an unreasonable burden on Mohave's

1 existing customers. Mohave has not had a dedicated source of funding of any of these
2 programs, but has implemented many of them out of its general revenues, even though the
3 costs of all existing programs were removed from its existing rates because they were to be
4 funded through the tariff requested by these dockets.

5 Staff has recommended approval of all programs and at budgets requested by
6 Mohave. Mohave agrees with and supports the Staff's Report and asks the Commission to
7 approve the Proposed Order as a consent item on its April 8th Open Meeting. Mohave extends
8 its appreciation to Staff for its thorough evaluation of Mohave's plan.


