NOTIFICATION OF
INTERVENTION

BY THE COMMISSION:

On January 10, 2014, UNS Energy Corporation ("UNS Energy") on behalf of itself and its affiliates, and Fortis Inc. ("Fortis") on behalf of itself and its affiliates, (collectively, "Joint Applicants") filed with the Arizona Corporation Commission ("Commission") pursuant to Arizona Administrative Code ("A.A.C.") R14-2-803 a Joint Notice of Intent to Reorganize ("Joint Notice").

On March 21, 2014, Mohave Electric Cooperative, Inc. ("MEC") filed a Motion to Intervene in this matter. MEC states it provides electric service in an area adjacent to UNS Electric, Inc. ("UNSE") which is one of the Joint Applicants. MEC states it will be directly and substantially affected by the proceeding because of a number of inter-relationships, such as borderline agreements and joint use of facilities, etc.

On March 25, 2014, the City of Nogales ("Nogales") filed an Application to Intervene. Nogales states that it maintains a number of facilities that receive electric and gas service from UNSE and UNS Gas, Inc., and also has franchise agreement with both entities.

No party objected to either request to intervene.




