
**AFFIDAVIT OF JASON P. WILLIAMSON**

# NOTICE OF IMPLEMENTATION OF SURCHARGE

BY PAYSON WATER CO., INC.

DOCKET NOs. W-03514A-13-0111 & W-03514A-13-0142

Arizona Corporation Commission Decision No. 74175 (Oct. 25, 2013) authorized Payson Water Co., Inc. (Company) to borrow up to \$275,000 from the Water Infrastructure Finance Authority of Arizona (WIFA) to finance the construction of a new water transmission line to connect its Mesa del Caballo system to the Town of Payson's water system.

Decision No. 74175 also authorized the Company to implement a surcharge once certain requirements were met. The new surcharge applies **only** to customers of the Mesa del Caballo system and will become effective on or after **April 1, 2014**.

The surcharge amounts are presented below.
