“41. On April 1, 2014, Lagoon Estates selected and docketed three proposed BMPs which include the Public Education Program, 3.6 (Customer High Water Use Inquiry), and 5.2 (Water System Tampering).

42. Staff concludes that the Company’s proposed BMP Tariffs are relevant to the Company’s service area and that the proposed BMP Tariffs conform to the templates developed by Staff. Staff recommends approval of the three BMP Tariffs docketed by the Company on April 1, 2014.”

IT IS FURTHER ORDERED that the Commission’s Utilities Division shall file a letter with Docket Control confirming that Lagoon Estates Water Company, Inc.’s tariffs have been updated with the tariffs approved herein.

IT IS FURTHER ORDERED that the Best Management Practices Tariffs approved herein shall go into effect 30 days after the date that notice is provided to customers.”
