On July 28, 2004, MCImetro Access Transmission Services, LLC (“MCImetro”) filed an application for approval of a negotiated amendment to an interconnection agreement and a QPP Master Service Agreement with Qwest Corporation.

On February 20, 2014, Staff filed a Memorandum recommending that these dockets be administratively closed, stating the agreements went into effect by operation of law. There were no objections to Staff’s recommendation.
