IN THE MATTER OF THE APPLICATION OF WIDE VOICE, LLC FOR APPROVAL OF A CERTIFICATE OF CONVENIENCE AND NECESSITY TO PROVIDE RESOLD LOCAL EXCHANGE, RESOLD LONG DISTANCE, FACILITIES-BASED LOCAL EXCHANGE, AND ACCESS TELECOMMUNICATIONS SERVICES.

PROCEDURAL ORDER
(Granting Telephonic Appearance)

BY THE COMMISSION:

On March 1, 2012, Wide Voice, LLC ("Wide Voice") filed with the Arizona Corporation Commission ("Commission") a Certificate of Convenience and Necessity ("CC&N"), to provide resold facilities-based local exchange, and access telecommunications services or

On December 19, 2013, Wide Voice filed an amended application to include resold long distance telecommunications services for which it is seeking a CC&N.

On December 30, 2013, Wide Voice filed a second amended application to incorporate revisions to Tariff No. 1 and Tariff No. 2.

On January 17, 2014, the Commission's Utilities Division ("Staff") filed its Staff Report recommending approval of Wide Voice's amended application, subject to certain conditions.

On February 14, 2014, a Procedural Order was issued setting the date for hearing in this matter, and establishing other procedural deadlines.

On March 18, 2014, Wide Voice filed an Affidavit of Publication indicating that notice of the application and hearing date had been published in the *Arizona Republic*, a newspaper of general circulation in Arizona.

On March 27, 2014, Matthew G. Bingham of Lewis Roca Rothgerber LLP filed his Notice of Appearance on behalf of Wide Voice.

1 On March 31, 2014, Wide Voice filed a Request to Allow Witness to Appear Telephonically
2 (“Request”) for the April 14, 2014 hearing. The Request also stated that Staff had no objection to the
3 witness appearing telephonically.

4 No objections to the Request were filed, accordingly, the Request should be granted.

5 IT IS THEREFORE ORDERED that the **hearing** in the above-captioned matter shall be held
6 on **April 14, 2014 at 10:00 a.m.**, or as soon thereafter as is practical, at the Commission’s office,
7 1200 West Washington St., Hearing Room No. 1, Phoenix, Arizona 85007.

8 IT IS FURTHER ORDERED that the witness for Wide Voice, LLC is authorized to appear
9 telephonically at the April 14, 2014 hearing.

10 IT IS FURTHER ORDERED that on the date of and at least five minutes before the time set
11 for the hearing, Wide Voice’s witness shall call 1 (800) 689-9374, passcode 415962#, from a landline
12 telephone, to participate telephonically in the hearing.

13 IT IS FURTHER ORDERED that all parties must comply with Arizona Supreme Court Rules
14 31, 38, and 42 and A.R.S. § 40-243 with respect to practice of law in Arizona and before the
15 Commission and admission *pro hac vice*.

16 IT IS FURTHER ORDERED that withdrawal of representation must be made in compliance
17 with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Arizona
18 Supreme Court Rule 42). Representation before the Commission includes appearance at all hearings
19 and procedural conferences, as well as all Open Meetings for which the matter is scheduled for
20 discussion, unless counsel has previously been granted permission to withdraw by the Administrative
21 Law Judge or the Commission.

22 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized
23 Communications) applies to this proceeding and shall remain in effect until the Commission's
24 Decision in this matter is final and non-appealable.
