**STAFF'S REQUEST FOR AN EXTENSION
OF TIME TO FILE RESPONSE**

The Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") hereby requests an extension of time to file its response to the Company in the above captioned matter.

On March 5, 2014, Staff docketed its Staff Report in the rate case for Q Mountain Mobile Home Park dba Q Mountain Vista Water ("Q Mountain" or "Company").

On March 17, 2014, Q Mountain docketed a response to the Staff Report.

On March 28, 2014 the Administrative Law Judge issued a procedural order requesting Staff respond to Q Mountain. It was ordered that Staff file its response on or before April 18, 2014.

On March 31, 2014, and April 9, 2014 the Company filed two more responses to the Staff Report bringing up additional concerns.

Staff would request an extension of two (2) weeks to May 2, 2014. This will allow Staff sufficient time to properly respond to all of the Company's concerns. Staff has communicated with the Company and they have no objection to the extension.
