PROCEDURAL ORDER

BY THE COMMISSION:

A hearing in this matter was held on March 25, 2014. During the hearing, Table Talk Telephone Company, Inc. ("Table Top" or "Company") was requested to file the total amount of compensation in the test year, and also to break out if there were any salaries or compensation paid to officers or directors of the Company.¹

On April 1, 2014, Tale Top filed post-hearing exhibits include Exhibit A-6, which sets out the regulated payroll for the year 2012. Exhibit A-6 does not include any amount paid in salaries or benefits to officers and directors.² It is unclear, however, if there was no salaries or benefits paid to officers or directors of Table Top, or the information was inadvertently omitted.

IT IS THEREFORE ORDERED that Table Top shall supplement the record with information on whether, or not, any salaries or compensation were paid to officers or directors in the test year.


