On February 5, 2014, The
Town of Queen Creek filed
with the Arizona Corpora-
tion Commission ("Commis-
sion") an application for ap-
proval for the Union Pacific
Railroad to upgrade an ex-
isting crossing at Ocotillo
Road in Queen Creek,
Maricopa County, Arizona at
AAR/DOT No. 741-837-W.

The application is available
for inspection during regu-
lar business hours at the
Commission's offices, 1200
West Washington Street,
Phoenix, Arizona, and on
the internet via the Commis-
sion website (www.azcc.gov) using the e-docket
function.

The Commission will hold a
hearing on this matter com-
mencing on April 25, 2014,
at 10:00 a.m., at the Com-
mission's offices, 1200 West
Washington Street, Hearing
Room No. 1, Phoenix, Ariz-
ona. Public comments will be
taken on the first day of the
hearing.

The law provides for an
open public hearing at
which, under appropriate
circumstances, interested
parties may intervene. In-
tervention shall be permit-
ted to any person entitled
by law to intervene and hav-
ing a direct and substantial
interest in the matter. Per-
sons desiring to intervene
must file a written motion
to intervene with the Com-
mission, which motion
should be sent to Applicant
or its counsel and to all par-
ties of record, and which, at
the minimum, shall contain
the following:

1. The name, ad-
dress, and telephone num-
ber of the proposed inter-
venor and of any party upon
whom service of documents
is to be made if different
than the intervenor.
2. A short state-
ment of the proposed inter-
venor's interest in the pro-
ceeding (e.g., a customer of
Railroad, a Neighboring
property owner, a crossing
user, etc.).
3. A statement
certifying that a copy of the
motion to intervene has
been mailed to the Appli-
cant or its counsel and to all
parties of record in the
case.

The granting of motions to
intervene shall be governed
by A.A.C. R14-3-102, except
that all motions to intervene
must be filed on or before
March 26, 2014. The grant-
ing of intervention, among
other things, entitles a party
to present sworn evidence
at hearing and to cross-
examine other witnesses.
However, failure to inter-
vene will not preclude any
customer from appearing at
the hearing and make a
statement on such custom-
er's own behalf.
