In its Decision No. 67977, in Docket No. T-03406A-04-0232, the Commission ordered that by June 30<sup>th</sup> of each year Eschelon Telecom of Arizona, Inc. (Eschelon) is to "provide to Staff the allocated Arizona percentage of actual capital expenditures by the categories listed on the Company's website and provided to the Securities and Exchange Commission." Eschelon has analyzed its 2009-2013 capital expenditures and determined the following with respect to the percentage of each expenditure category applicable to the Company's Arizona operations:
