

 E-00000C-11-0328 ON OPT-OUT FEES,  
 TERMS AND CONDITIONS**

22 Arizona Public Service Company (the "Company" or "APS") responds to the City of  
 23 Sedona's ("City") Motion in the above-captioned matter. APS does not object to the proper  
 24 use of Official Notice per A.A.C. R14-3-109(T). However, much of the voluminous material  
 25 filed in Docket No. E-00000C-11-0328 ("Generic Docket") is wholly irrelevant to the  
 26 Company's request for approval of Service Schedule 17 and some of it does not even relate to  
 27 APS, but rather to other electric utilities. APS suggests that the City first identify those  
 28 filings in the Generic Docket of which it requests the Commission take Official Notice. Then

1 the Company and other parties to this Docket would be in a better position to respond to the  
2 City's Motion, and the Administrative Law Judge would be better able to determine whether  
3 and to what extent the City's Motion should be granted.

4 Second, APS also notes that by not opposing the taking of Official Notice of a  
5 document, the Company has not in any way conceded or admitted that the document is either  
6 relevant or accurate. The Company reserves the right to assert any and all applicable  
7 objections to any noticed documents and expects that if a Noticed document is to be given  
8 any evidentiary weight, it will be formally admitted into the record at any hearing in this  
9 matter and subject to cross-examination and rebuttal by APS and other parties.
