On March 19, 2014, the Arizona Corporation Commission (Commission) issued Decision No. 74407 ("the Decision") which approved a corporate reorganization resulting in the consolidation of Qwest Communications Company LLC ("QCC"), Qwest LD Corp. ("QLDC"), and Embarq Communications, Inc. ("ECI"), with QCC as the surviving entity and provider of telecommunications services now provided by QLDC and ECI. QCC is now known as CenturyLink Communications, LLC.

5. Final documents from the Arizona Corporation Commission regarding the merger were received on May 2, 2014.


