IT IS FURTHER ORDERED that to ensure the Commission is apprised of Montezuma Rimrock Water Company, LLC's performance and conduct, the Commission's Utilities Division shall monitor Montezuma Rimrock Water Company, LLC's compliance with this Decision for the next 24 months. Every six months from the effective date of this Order and for a period of 24 months, the Company shall file a compliance report regarding its adherence to the requirements of this Decision and Commission rules, regulations and statutes. Within 2 months after each of the Company's filing, Staff shall file a Compliance Report detailing the status of Montezuma Rimrock Water Company, LLC's compliance with this Decision and with all applicable Commission statutes, rules, Decision and Orders during the period in question and making a recommendation concerning the Company's compliance or lack thereof, and whether a Show Cause proceeding should be initiated and other adverse action taken.
