Dear Parties in the Docket:

In the context of Payson Water Company's pending rate case, I am interested in exploring different rate designs for the PWAM for Mesa Del Caballo. I would like to be able to consider alternative methodologies at the June open meeting. To that end, I would ask that the Company file the following sample information in the docket:

1. Select a customer who was a low usage customer in May 2013, i.e., usage fell within the first tier, and provide the bills for that customer for each month from May through September of 2013. Please redact all identifying information for the customer.
2. Select a customer who was a medium usage customer in May 2013, i.e., usage fell within the second tier, and provide the bills for that customer for each month from May through September of 2013. Please redact all identifying information for the customer.
3. Select a customer who was a high usage customer in May 2013, i.e., usage fell within the third tier, and provide the bills for that customer for each month from May through September of 2013. Please redact all identifying information for the customer.

Please provide this information by Friday, May 30, 2014. I have not yet determined how best to resolve the issues presented by this case. This information will be helpful to me in my future full consideration of this matter. I look forward to your prompt response.
