STAFF RESPONSE TO JOHNSON MOTION
TO WITHDRAW APPLICATION

The Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") submits its response to the motion of Johnson Utilities LLC ("Johnson" or "Company") to withdraw its application in the above referenced docket.

Johnson filed an application for Commission approval to transfer the Company's assets to the Town of Florence and to cancel its certificate of convenience and necessity on December 31, 2013. A hearing on the matter was held from May 19 to May 21, 2014. On May 25, 2014, Johnson filed a motion to withdraw its application. According to the letter attached to Johnson's motion, the Company has determined that the Town no longer intends to pursue the transaction.

Staff has no objection to the Company's motion to withdraw. Staff would respectfully recommend that the Administrative Law Judge issue a procedural order, granting the Company's motion to withdraw. In the alternative, Staff would also suggest that this docket could be administratively closed.
