

A9 Senior Telephone Discount Program (STDP) (continued)

B7 Low-income customers who qualify under the Senior Telephone Discount Program, (otherwise known as Arizona's Low Income Telephone Assistance Program (ALITAP)) will receive an allowance equal to the current federally mandated primary residence End User Common Line (EUCL) charge which is discounted 100% as set forth in Frontier's Tariff FCC No. 6, as well as an additional allowance equal to the current Federal Lifeline Support credit. STDP/ALITAP customers are also eligible to receive additional state Lifeline support in an amount equal to 17% discount of local service charges.
