
On February 25, 2014, Business Discount Plan, Inc. (“BDPI”) and Central Telecom Long Distance, Inc. (“CTLDI”) (together, “Applicants”) filed a joint application requesting approval of BDPI to acquire the Arizona customers, including customer contracts of CTLDI, through a mutually negotiated customer base acquisition. On May 16, 2014, the Applicants filed a letter withdrawing their application.

Per the memorandum on June 13, 2014 by Steven M. Olea, Director of the Utilities Division, Staff has no objection to Applicants’ request to withdraw its application and this docket should be closed. Therefore, this docket is administratively closed.
