

RE: Not-so-smart APS AMI WMD CONTROL

Dear Commissioners,

**ORIGINAL** 

The *not-so-smart* **AMI WMD** *cancer causing mechanism*, that we need to avoid in Arizona, first came to the attention of Dr. George Carlo, during the 28.5 million dollar study he directed for the cell phone industry. **Non-thermal formation of micronuclei appeared repeatedly.** The cell phone industry sought to repress the information. APS has not warned us of our highly increased exposure to micronuclei formation from APS **'Smart' Automated Meter Infrastructure** (AMI) radiation.

Micronuclei, non-thermally induced cancer formations, were induced in cell phone users at .7 and .8 watts per kilogram. FCC thermal guidelines are 1.6 watts per kilogram. The FCC guidelines support industry sales. The FCC guidelines are clearly not biologically based safety standards.

Micronuclei are created when double strand DNA breaks take place. Micronuclei indicate disruption in DNA repair. They are caused by nuclear radiation and they are caused by cell phone and AMI microwave radiation. Two pathways: same cancer causing results.

Micronuclei<sup>2</sup> are formed when fragments of DNA produce a cell membrane and reproduce themselves as if they were whole healthy DNA cells.

Finding micronuclei is a very serious. Micronuclei impact the repair job that the body is expected to do. "Smart" AMI induction of micronuclei is what makes it a WMD.

Dr. Carlo's mobile industry study involved 200 research doctors and 15 epidemiological studies from 1993 to 1999.<sup>3</sup>

After the Chernobyl disaster took place, Russian citizens were tested for micronuclei. Dr. Carlo said that if micronuclei were present, a Russian person was treated as a cancer patient.

According to Dr. George Carlo, the FCC is a commission based agency and does not have the authority to set safety standards. Industry points to **1.6 watts** per kilogram as a safety standard but it is **NOT a safety standard**. Industry says it meets "all of the applicable safety standards" forgetting to tell the public that **there are no applicable FCC safety standards!** 

#### **APS PROTECTS ITS WMD AMI**

With regard to the APS Research Department, I requested information about EPA Smart Meter standards. The answer was a spin doctored APS MYTH<sup>5</sup>:

"APS has reviewed EPA health and safety standards of smart meters. After review, none of the EPA standards showed smart meters to be in breach of their standards."

After a number requests for the specific EPA documents reviewed by APS, I received an honest answer from staff:

"There are no EPA safety standard documents referring to smart meters, so of course 'smart' meters are not in breach of no standards."
