You will find enclosed a packet of petition signatures gathered by members of the "Let's Stand Together Again" Group. These 264 signatures represent a sampling of the opposing sentiments regarding the harsh 45% increase desired by EPCOR /Wishing Well Wastewater Treatment Plant in Fort Mohave, Mohave County, Arizona. Many more signed the online petition.

We have compiled them in different categories to make it clear to you how inequitable and burdensome EPCOR'S requested rate increase is and the effect it will have on these 1448 households.

- ◆ The majority are on fixed Social Security incomes. The Medicare increase wiped out the Social Security increase, while the cost of groceries, gasoline, medications etc. have increased.
- ◆ Many homes have no one living in them; several vacant lots are within EPCOR's service area.
- ◆ Many more homes belong to "snowbirds" and lie vacant at least a half-year.
- ◆ Several have signatures of only one homeowner, because the spouse/partner was too ill to come to the door at the time we visited.
- ◆ Several signatures are those who are currently on their own septic systems. They know their future is uncertain; that they could be coerced into connecting with a sewer service at the cost of thousands of dollars.

In a recent article from the Las Vegas Review Journal, San Diego, CA was listed as having the fourth highest sewer rate among America's fifty larger cities. I asked a friend from San Diego to share her sewer bill with you. I've attached a copy which shows she pays less per month than we do. Mohave County is one of the most economically challenged counties per capita in all of Arizona.


There is no part of this request that is fair or necessary. Please take a good look at the picture included of the tiny Wishing Well treatment plant. If the Fort Mohave Tribal Assn. (FMTA) can operate their nearby plant by charging each of their customers \$44.00/mo., then EPCOR can do the same.

During a recent rainstorm, the Wishing Well plant was under water threatening to flood sewage into the abutting Desert Lakes subdivision. Instead of the Cavalry riding to the rescue, the Native Americans (FMTA) graciously agreed to somehow take the overflow into their plant. If this can be done so easily, we'd rather have the FMTA provide our service. (See MAP and PHOTO)

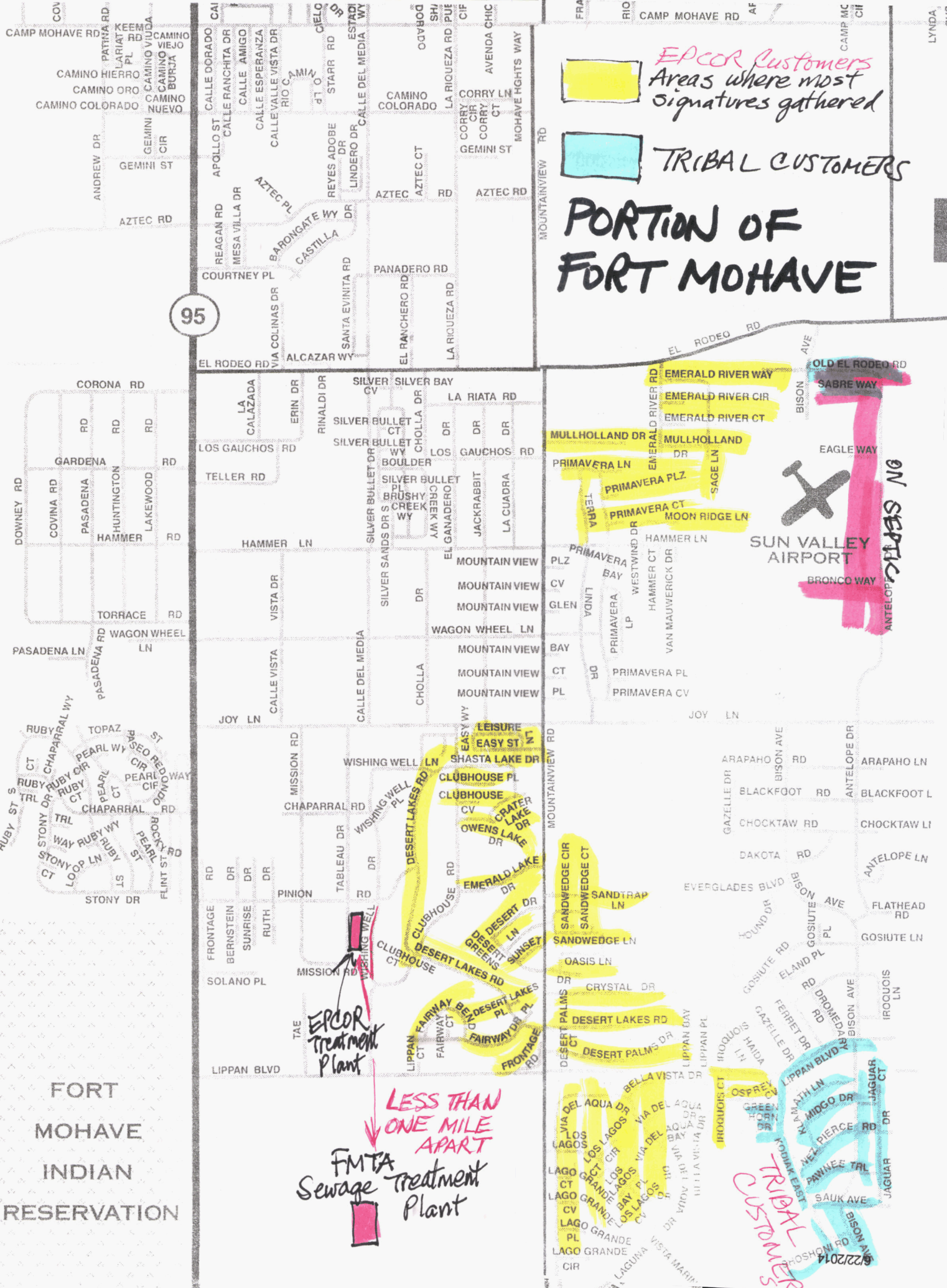
From my personal perspective, our neighbors immediately adjacent to our property have FMTA service. We currently pay \$56.67/mo to their \$44/mo. The proposed increase will affect the future sales of our homes. Buyers will run when they learn of our exorbitant utility costs. Elderly people are being forced to either sell at a great loss or walk away with nothing, losing the nest egg they'd planned for Assisted Living costs, Hospice Care and funeral expenses. Please give this matter your utmost consideration. We made several attempts to communicate by phone and email with EPCOR's Canadian corporate offices. Return phone calls were promised with no response. E-mails were ignored. Therefore we have no recourse but to stand together against them. Please stand with us.
