

**NOTICE OF COMPLIANCE FILING**

On January 7, 2014, the Arizona Corporation Commission (Commission) issued Decision No. 74244 which approved Qwest Corporation d/b/a CenturyLink QC's ("CenturyLink")<sup>1</sup> Petition to modify the Performance Assurance Plan (PAP) and Performance Indicator Definitions (PIDs).
