On April 2, 2014, Citizens Telecommunications Company of the White Mountains, Inc. dba Frontier Communications of the White Mountains, Citizens Utilities Rural Company, Inc. dba Frontier Citizens Utilities Rural, Navajo Communications Company, Inc. dba Frontier Navajo Communications Company and Frontier Communications of the Southwest Inc., on behalf of their parent corporation, Frontier Communications Corporation ("Frontier"), filed an Application at the Arizona Corporation Commission ("Commission") for a Limited Waiver of the Affiliated Interest Rules in relation to Frontier's proposed acquisition of The Southern New England Telephone Company ("SNET") and SNET America, Inc. ("SNET America").

Pursuant to Arizona Administrative Code ("A.A.C.") R14-2-806.C., the waiver has become effective on the 31<sup>st</sup> day (May 3, 2014) following filing of the Application. Staff recommends that this docket be administratively closed.
